Symposium Format

2018 marks the tenth time that SI Arb's Arbitration Bar Committee has convened the Commercial Arbitration Symposium. Always popular, the Symposium provides a distinctive and interactive forum for participants to discuss current issues and developments in the field of commercial arbitration.

The Symposium features no set speakers or speeches. The success of the Symposium is based on the free-flowing discussion of current issues, suggested by delegates. Delegates whose topics are chosen will be invited to introduce their questions or topics, which will then be followed by an open discussion under the moderation of the experienced co-chairs.

Each delegate is therefore invited to contribute upon registering at least 3 questions or topics for discussion. There is no limit to the number of topics that each delegate may contribute, and additional questions may be emailed to secretariat@siarb.org.sg. The topics will be grouped into themes and allocated to one of the three working sessions, but the titles of the sessions are not prescriptive; participants are encouraged to present questions on any matter relevant to the practice of commercial arbitration.

We return again to the Old Parliament House, with the working sessions of the Symposium held in the atmospheric surroundings of the former parliamentary debating chamber. About Our Session Chairs



The Honourable Justice Belinda Ang - Supreme Court of Singapore

Justice Ang was appointed Judicial Commissioner on 1 February 2002, and was appointed Judge of the Supreme Court of Singapore on 2 January 2003. Justice Ang sits as a specialist judge for Admiralty, Shipping and Arbitration matters.

Prior to these appointments, she was a lawyer in private practice and held the title of Senior Counsel (appointed in 1998). Justice Ang was a member of the sub-committee on the Review of Arbitration Laws, appointed by the Attorney-General in 1991, that made recommendations on Singapore's laws relating to international commercial arbitrations, and which led to the enactment of the International Arbitration Act (Cap 143).

Justice Ang is also in the Rules Committee, Supreme Court; the Senate and the Executive Board of the Singapore Academy of Law. Justice Ang is the Chairperson of the Singapore Mediation Centre.



Chiann Bao - Asia Pacific Counsel, Skadden, Arps, Slate, Meagher & Flom LLP (Hong Kong)

Chiann Bao is Asia Pacific Counsel based in Skadden's Hong Kong office. She represents corporates and state-owned enterprises in complex international commercial arbitration and litigation and occasionally acts as arbitrator. Ms. Bao serves as vice president of the ICC

International Court of Arbitration and was Secretary-General of HKIAC from 2010-2016. As a New York-qualified Mandarin speaking lawyer, Ms. Bao has worked in several jurisdictions, including New York and London. Ms. Bao regularly speaks and frequently writes on international arbitration.



Judith Gill QC - Arbitrator Member, 20 Essex Street Chambers

Judith is recognised as one of the leading practitioners in the field of international arbitration. She was a partner in the International Arbitration Group of global law firm Allen & Overy for more than 25 years and was Head of the Group for 11 years. She has particular experience of projects (especially in the energy and infrastructure sectors), joint ventures, distributorships, investor protection disputes, insurance claims and construction disputes.

Judith moved to Singapore in September 2015 and joined 20 Essex Street Chambers in Singapore in May 2018. Since joining Chambers Judith has practised exclusively as an arbitrator. She has extensive experience, both as sole arbitrator and as a member of a panel of three arbitrators, in matters involving construction disputes, energy contracts, manufacturing, distributorship agreements and other commercial agreements. In particular, Judith is regularly appointed as arbitrator in arbitrations conducted under the auspices of different institutions, including the ICC, SIAC, HKIAC, PCA and ICSID. Judith is currently the President of the LCIA Court, the first female to be appointed to the position. She was only the second female solicitor-advocate to be appointed QC in England.



Sapna Jhangiani - Partner, Clyde & Co Clasis Singapore

Sapna is called to the Bar of England and Wales, and practised in London, New York and Dubai before relocating to Singapore in 2011. She specialises in international arbitration and is recognised as a leader in this field by Who's Who Legal. She is said to be "a top name for

international arbitration in Singapore" and has been described by peers as "a charming advocate, who is well respected within the arbitration fraternity". Chambers and Partners Asia Pacific 2018 has recognized her as "tenacious in the pursuit of her clients' interests," adding that "she is very easy to get on with and always open to new ideas." Sapna has also been recommended by Legal 500 Asia Pacific 2018 & 2017 for International Arbitration. She specialises in commercial disputes, and has extensive experience in shipbuilding, trade and commodities, and hospitality disputes.

Sapna holds a degree from Oxford University, and graduated with distinction from Queen Mary University with a diploma in International Commercial Arbitration.



Sue-Hyun Lim - Secretary-General, KCAB International

Sue-Hyun Lim is the Secretary General of the new international division of the Korean Commercial Arbitration Board, KCAB INTERNATIONAL. Among her various responsibilities Ms. Lim oversees KCAB's international arbitration case management process, ensuring the

efficiency and cost-effectiveness of the procedures under the KCAB International Rules, as well as leading the public relations efforts to further enhance the standing of KCAB INTERNATIONAL in and Seoul as a seat of arbitration among international users.

A Korean licensed attorney, and also admitted to the New York State bar, Ms. Lim was a partner at Bae, Kim & Lee LLC, where she advised and represented clients in numerous international arbitration cases as well as in international litigation matters. In 2010-2011, Ms. Lim studied at the New York University School of Law (LL.M.) after which she worked as visiting lawyer in Debevoise & Plimpton LLP.

Featured in Who's Who Legal: Arbitration Future Leaders 2018, she has actively and continuously spearheaded efforts to promote international arbitration in Korea. Ms. Lim has written and co-written a number of published pieces, and is a contributing author to *Arbitration Law in Korea: Practice and Procedure* (Juris Publishing, 2012), the 2016 edition of *Arbitration, Practice and Law* (Parkyoungsa, 2016), and most recently the *Global Practice Guide for Litigation in South Korea* (Chambers and Partners, 2017).



Loretta Malintoppi - Arbitrator, 39 Essex Chambers

Loretta Malintoppi is an arbitrator with 39 Essex Chambers, based in Singapore.

Loretta is dually qualified (Paris and Rome Bars) and her company is registered as a Foreign Law Practice in Singapore. She specializes in international commercial arbitration, investment

arbitration and public international law. She sits as arbitrator in proceedings under a variety of arbitration rules, including ICSID, ICC, UNCITRAL, SIAC, LCIA and DIAC.

Loretta also appears as counsel and advocate in State-to-State disputes before the International Court of Justice and in ad hoc arbitrations.

She was a Member for Italy of the ICC International Court of Arbitration from 2000 to 2009 and served as a Vice-President of the ICC Court from 2009 until 30 June 2015. She currently is a member of the Governing Board of ICCA.

Loretta is one of the co-authors of *The ICSID Convention - A Commentary* published by Cambridge University Press in 2009. She is also a member of the Editorial Board of *The Law and Practice of International Courts and Tribunals*, editor of the *International Litigation in Practice Series*, and a member of the editorial advisory board of the *Journal of World Investment and Trade*.
